U.S. Expeditionary Forces in FRANCE, the Field-Marshal,  
Commander-in-Chief, French Forces in the EAST,  
has awarded a citation

TO THE ORDER OF THE DIVISION

To OKLAHOMBI Josef - Soldier - Registration number 1483 609 -  
Company D - 141th U.S. Infantry Regiment.

"Under a violent fire barrage, attacked the enemy's position by running over 200 meters through a maze of barbed wire. Swooped down on machine-gun pits, thus contributing to the capture of 171 prisoners.

Took part in the seizure of a strongly armed position containing more than 50 machine-guns and trench mortars.

Helped turn the captured equipment against the enemy and held out for four days, despite a constant barrage of large projectiles and gas shells.

Several times crossed the "NO MAN'S LAND" to collect information on the enemy and rescue his wounded comrades".

THESE CITATIONS INCLUDE THE AWARD OF THE "CROIX DE GUERRE" WITH SILVER STAR.

OKLAHOMBI Josef - soldat - Mle 1483 609 de la compagnie "D" du 141 Régiment  
d'Infanterie Américaine.

"Sous un barrage violent, s'est élancé à l'attaque d'une position  
ennemie parcourant environ deux cents mètres d'un réseau de fil de fer.  
S'est précipité sur des nids de mitrailleuses, contribuant à la capture de  
171 prisonniers. A participé à l'enlèvement d'une position puissamment  
armée contenant plus de 50 mitrailleuses et des mortiers de tranchée.  
A aidé à retourner les pièces capturées contre l'ennemi et a tenu 4 jours  
malgré un barrage constant de gros projectiles et d'obus à gaz. A maintes  
fois traversé le "NO MANS LAND" pour recueillir des renseignements sur  
l'ennemi et secourir ses camarades blessés".

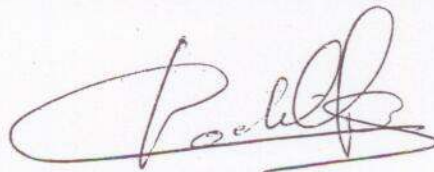

## INSTRUCTIONS

2. All officers, noncommissioned officers, and others that may be concerned in the preparation of this roll are enjoined to exercise every care that it be made complete. It is not only the guide for immediate payment of the men interested, but, when filed in the Treasury Department, it will become the record to which reference will thereafter be made in the investigation and settlement of all claims or questions affecting the men whose names are borne on the roll, and their heirs, for the period covered by it.
3. Columns marked "Q. M." will be filled in by Quartermaster; columns marked "P. A." will be filled in by officer preparing roll.
4. In column "Partial pay previously received" should be entered the total amounts previously received as partial pay only when soldier is credited on this pay roll with payments in full from date to which last paid in full. When settlement is not made in full and soldier is credited with partial pay on this pay roll, such amount will not be entered in this column.
